#### ORDER:-

The Hon'ble Chief Minister has announced in the Floor of the Tamil Nadu Legislative Assembly during the Budget Session for the year 2012-2013, that four new additional Revenue Courts will be formed at Lalgudi, Mannargudi, Tirunelveli and Nagapattinam to dispose the long pending tenancy cases.

2. Based on the said announcement made by the Hon'ble Chief Minister and the report of the Principal Secretary/Commissioner of Land Reforms, the Government in the Government Order first read above created four new additional Revenue Courts at Lalgudi, Mannargudi, Tirunelveli and Nagapattinam to dispose of the tenancy cases.

3. Consequent on the creation of above four Revenue Courts, the Principal Secretary/Commissioner of Land Reforms in the reference second read above has sent the proposal for the publication of Notification with regard to the revised jurisdiction of the six Revenue Courts already existed and also for four Revenue Courts created in the Government Order second read above.

4. The Government accept the proposal of the Principal Secretary/Commissioner of Land Reforms in the reference second read above and approve the draft Notifications for the revised jurisdictions of ten Revenue Courts in Cuddalore, Myiladuthurai, Tiruvarur, Thanjavur, Tiruchirappalli, Madurai, Mannargudi, Lalgudi, Tirunelveli and Nagapattinam.

5. The Works Manager, Government Central Press, Chennai is requested to publish the appended Notifications in respect of above ten Revenue Courts in the extraordinary Gazette and send ten copies of the Notifications to the Principal Secretary, Revenue Department, Secretariat, Chennai-9, twenty five copies of the Notifications to the Principal Secretary/Commissioner of Land Reforms, Chepauk, Chennai-5 and all addressees.
